CANCELLATION TERMS – If you have to cancel before DECEMBER 1 in 2017 your deposit payment is only 50 % refundable and if you cancel after this date your **deposit** cannot be refunded. [As tour providers we must put down non-refundable deposits to hold reservations of these exclusive hotels.]

As this is a private group tour it is important for you to have **Travel Insurance** to protect yourself against this eventuality as French Fusion Travel cannot guarantee any refunds after your payment has been made.

Final payment in full is required before APRIL 1 in 2018.
